Executive Summary

The past financial year has been incredibly busy for our little charity as we have gotten used to the mayhem that the COVID-19 virus has caused. On the plus side many people have been able to spend more time with their pets and there has been an increase in pet ownership as people experience unprecedented levels of social isolation and loneliness. This increase in pet ownership has placed a great deal of pressure on our wonderful veterinary community, so we thank all our vets and nurses from the bottom of our hearts for working tirelessly to support pet owners despite all the difficulties of curbside consultations.

Regardless of the pandemic, the charity was lucky enough to still be able to hold some events, but it made us really re-think the future of fundraising as a charity. We have also undertaken to trial a new platform to try and consolidate our documents and processes. The system is called Supporter Hub and we hope that all our fundraising will be managed by this system in the future. In the interim, our Secretary, Sue Thomas, has continued to work tirelessly thanking our regular and one-off donors by sending thank you cards and emails.

Last year we partnered with Dr. Vany and Oscar at Barton Shelter to accept surrendered animals. Unfortunately, with the relocation of Dr Vany and Oscar to Western Australia, the Barton Shelter has wound up its services, so we are no longer offering a service for surrendered animals.

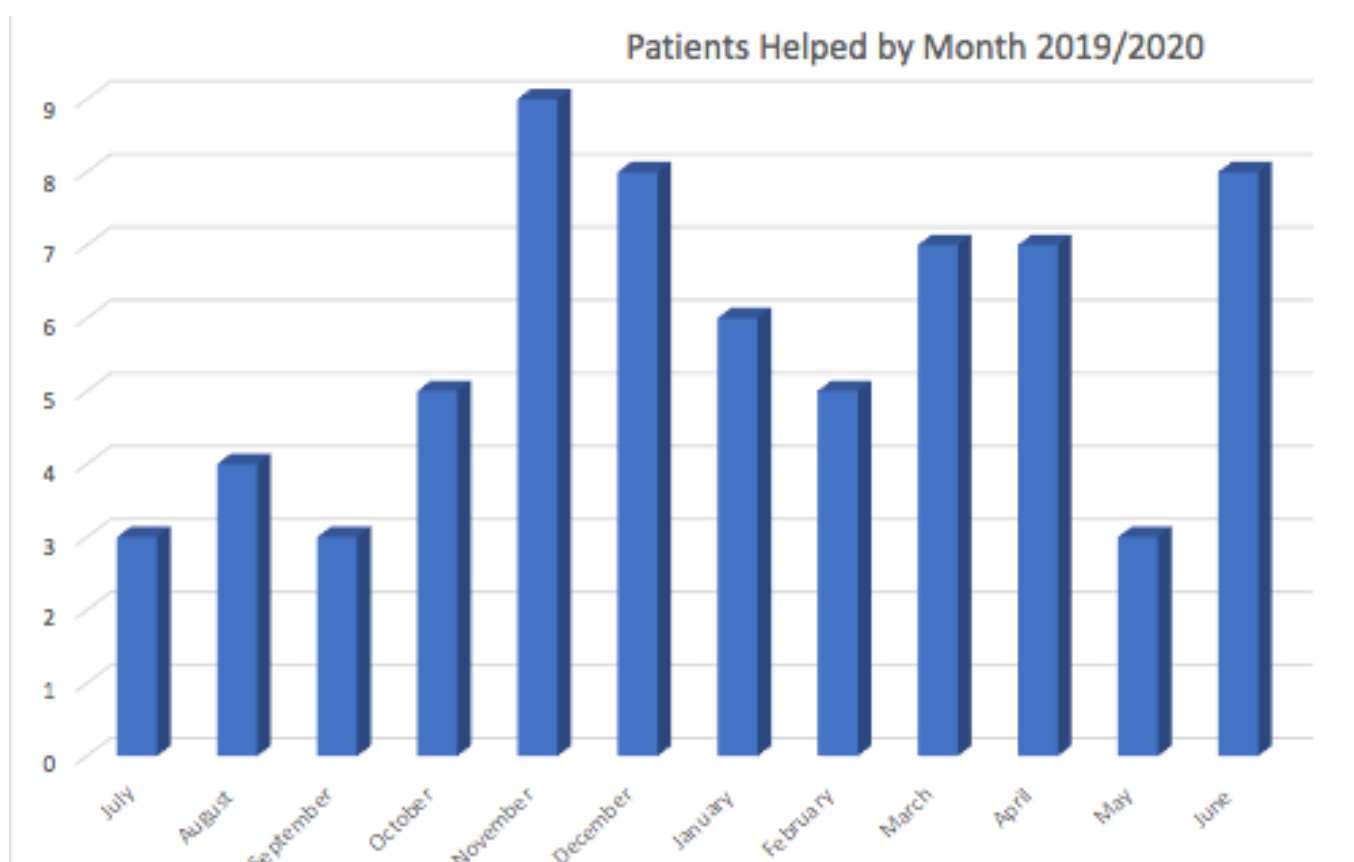
