It has been another incredibly busy year for our charity. The COVID-19 virus has continued to challenge us, not just in Canberra, but the nation as a whole. The pandemic, coupled with the increase in pet ownership and an 80% increase in requests for assistance, our finances have been impacted significantly. The charity was still lucky enough to hold some events, and we continued to re-think and re-imagine the future of fundraising as a charity.

Along with our fundraising, we were again fortunate to receive so many generous donations from people within Canberra Community and beyond. 
Heading into the next financial year, ACT Pet Crisis Support will continue to live our mission to:

“ensure that all pets in need owned by disadvantaged, low income pet owners in the ACT and local region, have access to veterinary care.”


# Patients Helped
